About the Private Sector Partnership Forum

The three-day Private Sector Partnership Forum has been organized in recognition of the critical roles played

by the private sector in innovating and piloting novel solutions to development challenges, and the public sector in scaling up successful innovations. To this end, the Forum seeks to facilitate partnership between national governments and municipalities with private sector companies, specifically investors and innovators with low-cost innovative solutions to development challenges.

Description of the Session

While developing countries have increased public investment in education, dedicating at least 20% of their public spending to education, sub-Saharan Africa still has the highest rates of education exclusion. It is estimated that approx. 20% of children aged between 6 and 11, approx. 35% of aged between 12 and 14 and 60% of youth aged between 15 and 17 are out of school. Worse still, is the shortage of learning materials and the dearth of trained teachers, which remains a significant challenge in many developing countries where the teacher-pupil ratio is higher than 40 students per trained teacher.

It is estimated that 95% of Africans lack access to basic healthcare and health insurance yet bear 25% of the global disease burden. Low public investment, poor infrastructure and a doctor-patient ratio of 1:25,000 have conspired to increase the cost of accessing basic treatment and the vulnerability of poor patients to substandard healthcare and counterfeit medicines.

In the current COVID-19 context, the poor, who lack access to the technologies needed to continue education have been hardest hit by school closures, particularly girls whose vulnerability to gender-based violence, child marriages and sexual exploitation increasing significantly. Similarly, for lacking access to affordable healthcare and health insurance, the pandemic has further reduced the resilience of the poor to economic shocks and stressors, as many are forced to resort to negative coping mechanisms during illness.

The session panellists and innovators will discuss the needs of communities, government priorities, the challenges and opportunities in the education and health sectors in African particularly in the current COVID-19 context, global trends and the investment requirements to meet the access challenge in these sectors. In addition, the innovators will briefly describe some of their innovative DigiTech-based and financial inclusion solutions that are successfully responding to these access challenges.

What measures can governments implement to address the quality of education and healthcare services in low-income market segments?
- ✓ Which key sector reforms would accelerate the realization of the education and health SDG? What has been the impact of recent policy reforms, and government plans and strategies on the education and health sectors in your country?

Expected Outcomes

The Forum is among a series of events organized by UN-Habitat to strengthen partnership with the business community to support sustainable and inclusive urban development and the New Urban Agenda. It provides a platform for matching the needs of informal settlements residents and demands of cities with innovative private sector solutions. The session is expected to have:

- 1. Demonstrated the business potential and identified opportunities to develop and deploy low-cost innovative education and health solutions in informal settlements
- 2. Identified opportunities for partnership and matched governments and investors with investable innovative solutions and models are explored
- 3. Identified bankable and investment-ready projects to be piloted in slums and informal settlements.
